

ORDINANCE NO. 2024- 05

**AN ORDINANCE OF THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY,  
ILLINOIS REGULATING THE HOURS THAT ALCOHOLIC LIQUOR MAY BE SOLD**

**WHEREAS**, the Village of Williamsfield, Knox County, Illinois ("Village") is authorized by Section 4-1 of the Illinois Liquor Control Act of 1934 ("Act") (235 ILCS 5/4-1) to establish regulations and restrictions upon the issuance of and operations under local licenses for sale at retail of alcoholic liquor not inconsistent with the Act as the public good and convenience may require; and

**WHEREAS**, Ordinance 2023-02, titled "An Ordinance Pertaining to the Regulation of the Retail Sale of Alcoholic Liquor for the Village of Williamsfield, Illinois," adopted by the Board of Trustees of the Village on February 6, 2023, provides that alcoholic liquor can be sold at establishments holding a Class "A" License between the hours of 6:00 a.m. and 2:00 a.m. on Mondays through Saturdays, and between the hours of 12:00 p.m. and 8:00 p.m. on Sundays; and

**WHEREAS**, the Board of Trustees of the Village finds it convenient and advisable to allow the sale of alcoholic liquor at establishments holding a Class "A" License between the hours of 6:00 a.m. and 2:00 a.m. on every day of the week, inclusive of Sundays.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Williamsfield, Knox County, Illinois as follows:

**Section 1:** The recitals hereinabove set forth are adopted and found to be true.

**Section 2:** Numbered Paragraph 9 ("TIME OF SALE"), Subparagraph (A), of Ordinance No. 2023-02, titled "An Ordinance Pertaining to the Regulation of the Retail Sale of Alcoholic Liquor for the Village of Williamsfield, Illinois," adopted by the Board of Trustees of the Village on February 6, 2023, is hereby amended as follows, with deletions indicated by ~~striketrough~~, and additions indicated by underline, such that said Paragraph 9, Subparagraph (A), of said Ordinance 2023-02, shall henceforth provide as follows:

"(A) Class A License – Except as provided in division (B) of this section for package sales,  
away upon  
6:00 a.m. no alcoholic liquor shall be sold, delivered, transferred, distributed or given  
or about any licensed premises by anyone except during the hours between  
and 2:00 a.m. following period of time on the following days:"

a.m. ~~"(1) Monday through Thursday of each week between the hours of 6:00  
and 2:00 a.m."~~

~~"(2) Friday through Saturday of each week between the hours of 6:00 a.m.  
and 2:00 a.m."~~

p.m." ~~"(3) On Sunday of each week between the hours of 12:00 p.m. and 8:00~~


All other portions of Ordinance 2023-02 shall remain unchanged by this amendment.

**Section 3:** This Ordinance is in addition to all other ordinances on the subject and shall be construed therewith excepting as to that part in direct conflict with any other ordinance, and, in the event of such conflict, the provisions hereof shall govern.

**Section 4:** This Ordinance is hereby ordered to be published in pamphlet form by the Williamsfield Village Clerk and the Village Clerk is hereby ordered to keep at least three (3) copies hereof available for public inspection in the future and in accordance with the Illinois Municipal Code.

**Section 5:** This Ordinance shall be in full force and effect upon its adoption, approval and publication as provided by law.
